**MEMORANDUM FOR THE DEPUTY CHIEF OF STAFF FOR PLANS AND
OPERATIONS, US AIR FORCE**

Subject: EF-111 Support to Bosnia (U)

1. ~~(S)~~ I share the concern you raised in your memorandum* regarding the effects of continued deployment of our EF-111 aircraft to three separate operating locations. To remedy the situation, a deployment order for USCINACOM to replace the EF-111s at Aviano with EA-6 aircraft NLT 25 September was released on 25 August. The order reduces the number of operating locations for EF-111s from three to two--Incirlik and Dhahran.
2. (U) The deployment order further directed USACOM, in coordination with USPACOM, to develop an integrated schedule for all operational deployments of EA-6/EF-111 aircraft through FY 1996. These actions will result in an achievable plan to meet the warfighting CINCs' requirements for EW support jamming aircraft.
3. (U) The Joint Staff POC is Lieutenant Colonel (b)(6)
