-- Aaron will inform Wahl (in Paris, Wednesday, February 7) on Brzezinski's behalf that: the US will [REDACTED]

[REDACTED] we are interested in enhanced political cooperation as in support on SALT II and non-proliferation and will be pursuing relevant matters in appropriate channels.

-- Perry will inform Martre and Bourges (in Paris, Thursday, February 9) on Brown's behalf of [REDACTED]

[REDACTED] Perry will note that Brown will want to review the French response with Bourges during his Paris visit in May.

-- Brown will follow-up with Bourges in May in Paris.

5. State in coordination with DoD will do a basic legal review of the draft PD circulated for the February 2 meeting, to be completed by February 9 for submission to the President.
